

LIEUTENANT GOVERNOR CARLOS LOPEZ-CANTERA

Carlos Lopez-Cantera was appointed as Lieutenant Governor on January 14, 2014, and began serving on February 3, 2014 and was subsequently elected in November of 2014. He is the first Hispanic elected to hold this position in Florida. He has been part of the team that has brought over 850,000 jobs to the state of Florida, lowered taxes for Florida families, reduced government regulation and increased education spending and achievement for Florida's students, including making higher education more affordable for Florida's students and veterans.

Carlos Lopez-Cantera was born in Madrid, Spain on December 29, 1973. He was born two months premature and was returned to his intended birthplace of Miami, Florida once he was healthy enough to travel. He graduated from Miami-Dade College and continued his studies at the University of Miami, where he graduated with a degree in Business Administration.

From 2004 through 2012, Carlos served as a member of the Florida House of Representatives. Over the course of his 8-year term in the Legislature, Carlos served as a member of the Governor's Property Tax Reform Committee, the My

Safe Florida Home Advisory Council and the Miami-Dade County Mayor's Mortgage Fraud Task Force. In the Florida House of Representatives, he chaired the Committee on Business Regulation and the Government Affairs Committee. Carlos served as Majority Whip from 2009 through 2010 and as the Majority Leader of the Florida House of Representatives during the final two years of his term from 2010 through 2012.

In August 2012, the citizens of Miami-Dade County elected Carlos Lopez-Cantera as the Property Appraiser of Miami-Dade County. Carlos campaigned on a platform to make interaction with the office of the property appraiser easier, increasing community outreach and being more responsive to the needs of the residents of Miami-Dade.


Carlos has been married to his wife Renee since 2005, and they have two young daughters.

Chip passed away on August 5, 2011, and in recognition of his many years of service and dedication to Florida's outdoor advertising industry, the annual FOAA golf tournament was renamed to "The M.A. "Chip" LaBorde Memorial Golf Tournament". This year, in lieu of golf, a fishing tournament will be held in honor of a man whose legacy, fervor and contributions to the outdoor industry will always be remembered.
